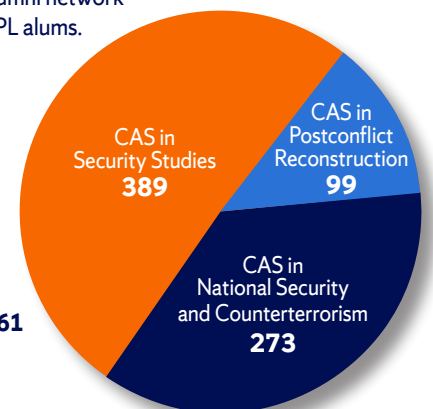
Students have the option of working on their certificates of advanced study while taking three-year joint law and graduate degree programs, including:
